



# **ALGO FOUNDRY**

## **Terms & Conditions**

**Last updated: 10 June 2022**

### **OVERVIEW**

These terms of service, together with any documents and additional terms they expressly incorporate by reference (collectively, these “Terms”), are entered into between Algo Foundry Pte Ltd (“Algo Foundry,” “we,” “us” and “our”) and you or the company or other legal entity you represent (“you” or “your”), and constitute a binding legal agreement. Please read these Terms carefully, as these Terms govern your use of our Portal and our Services, and expressly cover your rights and obligations, and our disclaimers and limitations of legal liability, relating to such use. By accessing or using our Portal or our Services, you accept and agree to be bound by and to comply with these Terms, including the mandatory arbitration provision in Section 12. If you do not agree to these Terms, you must not access or use our Portal or the Services.

You must be able to form a legally binding contract online either on behalf of a company or as an individual. Accordingly, you represent that: (a) if you are agreeing to these Terms on behalf of a company or other legal entity, you have the legal authority to bind the company or other legal entity to these Terms; and (b) you are at least 18 years old (or the age of majority where you reside, whichever is older), can form a legally binding contract online, and have the full, right, power and authority to enter into and to comply with the obligations under these Terms.

Please carefully review the disclosures and disclaimers set forth in Section 9 in their entirety before using any software developed by Algo Foundry. The information in Section 9 provides important details about the legal obligations associated with your use of the Algo Foundry open-source software.

By accessing or using our Portal or our Services, you agree that Algo Foundry does not provide execution or clearing services of any kind and is not responsible for the execution or clearing of transactions automated through Algo Foundry open-source software.

## **1. KEY DEFINITIONS**

For the purpose of these Terms, the following capitalised terms shall have the following meanings:

“Affiliate” means, with respect to a party to these Terms, any legal entity that, directly or indirectly controls, is controlled by, or is under common control with such party. “Applicable Law” means any domestic or foreign law, rule, statute, regulation, by-law, order, protocol, code, decree, or other directive, requirement or guideline, published or in force which applies to or is otherwise intended to govern or regulate any person, property, transaction, activity, event or other matter, including any rule, order, judgement, directive or other requirement or guideline issued by any Governmental Authority having jurisdiction over Algo Foundry, you, the Portal or the Services, or as otherwise duly enacted, enforceable by law, the common law or equity.

“Applicable Law” means any domestic or foreign law, rule, statute, regulation, by-law, order, protocol, code, decree, or other directive, requirement or guideline, published or in force which applies to or is otherwise intended to govern or regulate any person, property, transaction, activity, event or other matter, including any rule, order, judgement, directive or other requirement or guideline issued by any Governmental Authority having jurisdiction over Algo Foundry, you, the Portal or the Services, or as otherwise duly enacted, enforceable by law, the common law or equity.

“ALGO” means the Algorand Blockchain utility token that may be used to purchase computational resources to run decentralised applications or perform actions on the Algorand Blockchain.

“Algorand Address” means the unique public key cryptocurrency identifier that points to an Algorand-compatible wallet to which ALGO may be sent or stored. 1.5 “Algorand Blockchain” means the underlying blockchain infrastructure which the Portal leverages to perform portions of the Services.

“Governmental Authority” includes any domestic or foreign federal, provincial or state, municipal, local or other governmental, regulatory, judicial or administrative authority.

“Portal” means the Algo Foundry site located at [www.AlgoFoundry.finance](http://www.AlgoFoundry.finance), and all associated sites linked thereto by Algo Foundry and its Affiliates, which includes, for certainty, Algo Foundry’s decentralised application layer on the Algorand Blockchain.

“Services” has the meaning set out in Section 3.1.

## **2. MODIFICATIONS TO THESE TERMS**

We reserve the right, in our sole discretion, to modify these Terms from time to time. If we make changes, we will provide you with notice of such changes, such as by sending an email, providing a notice through our Services or updating the date at the top of these Terms. Unless we say otherwise in our notice, any and all such modifications are effective immediately, and your continued use of our Services after we provide such notice will confirm your acceptance of the changes. If you do not agree to the amended Terms, you must stop using our Services.

## **3. SERVICES**

**3.1 Services** - The primary purpose of the Portal is to enable users to interact with smart contracts and hedge against risk or gain exposure to risk via the option positions (the “Services”).

**3.2 Gas Charges** - You acknowledge and agree that Algo Foundry has no control over: (a) any Blockchain transactions; (b) the method of payment of any Gas Charges; or (c) any actual payments of Gas Charges. Accordingly, you must ensure that you have a sufficient balance of cryptocurrency stored at your respective Wallet Address to complete any transaction on any Blockchain before initiating any Blockchain transaction.

With your use of the Services, you agree to bear all costs necessary to conduct a transaction, such as gas cost. We will make reasonable efforts to notify you of any Gas Charges before initiating any Services that require the use of the respective Blockchain, but this information is highly volatile and can change quickly without Users necessarily being aware of these changes.

**3.3 Conditions and Restrictions** - We may, at any time and in our sole discretion, restrict your access to, or otherwise impose conditions or restrictions upon your use of, the Services or the Portal, with or without prior notice.

**3.4 No Broker, Legal or Fiduciary Relationship** - Algo Foundry is not your broker, lawyer, intermediary, agent, or advisor and has no fiduciary relationship or obligation to you regarding any other decisions or activities that you effect when using the Portal or the Services. Neither our communications nor any information that we provide to you is intended as, or shall be considered or construed as, advice.

**3.5 Your Responsibilities** - As a condition to accessing or using the Services or the Portal, you shall: (a) only use the Services and the Portal for lawful purposes and in accordance with these Terms; (b) ensure that, at all times, all information that you provide on the Portal is current, complete and accurate; and (c) maintain the security and confidentiality of your Algorand Address.

**3.6 Unacceptable Use or Conduct** - As a condition to accessing or using the Portal or the Services, you will not: (a) violate any Applicable Law, including, without limitation, any relevant and applicable anti-money laundering and anti-terrorist financing laws, such as the Bank Secrecy Act, each as may be amended; (b) infringe on or misappropriate any contract, intellectual property or other third-party right, or commit a tort while using the Portal or the Services; (c) use the Services in any manner that could interfere with, disrupt, negatively affect, or inhibit other users from fully enjoying the Services, or that could damage, disable, overburden, or impair the functioning of the Services in any manner; (d) attempt to circumvent any content filtering techniques or security measures that Algo Foundry employs on the Portal, or attempt to access any service or area of the Portal or the Services that you are not authorized to access; (e) use the Services to pay for, support, or otherwise engage in any illegal gambling activities, fraud, money-laundering, or terrorist activities, or other illegal activities; (f) use any robot, spider, crawler, scraper, or other automated means or interface not provided by us, to access the Services or to extract data; (g) introduce any malware, virus, Trojan horse, worm, logic bomb, drop-dead device, backdoor, shutdown mechanism or other harmful material into the Portal or the Services; (h) provide false, inaccurate, or misleading information; (i) post content or communications on the Portal that are, in our sole discretion, libelous, defamatory, profane, obscene, pornographic, sexually explicit, indecent, lewd, vulgar, suggestive, harassing, hateful, threatening, offensive, discriminatory, bigoted, abusive, inflammatory, fraudulent, deceptive or otherwise objectionable; (j) post content on the Portal containing unsolicited promotions, political campaigning, or commercial messages or any chain messages or user content designed to deceive or trick the user of the Service; (k) use the Portal or the Services from a jurisdiction that we have, in our sole discretion, or a relevant Governmental Authority has determined is a jurisdiction where the use of the Portal or the Services is prohibited; or (l) encourage or induce any third party to engage in any of the activities prohibited under this Section 3.7.

**3.7 Your Assumption of Risks** - You represent and warrant that you: (a) have the necessary technical expertise and ability to review and evaluate the security, integrity and operation of any option position; (b) have the knowledge, experience, understanding, professional advice and information to make your own evaluation of the merits, risks and applicable compliance requirements under Applicable Law of any option position; (c) know, understand and accept the risks associated with your Algorand Address, the Algorand Blockchain, ALGO and option Positions; and (d) accept the risks

associated with option Positions, and are responsible for conducting your own independent analysis of the risks specific to any option Positions. You hereby assume, and agree that Algo Foundry will have no responsibility or liability for, such risks. You hereby irrevocably waive, release and discharge all claims, whether known or unknown to you, against Algo Foundry, its affiliates and their respective shareholders, members, directors, officers, employees, agents and representatives related to any of the risks set forth herein.

**3.8 - Risk of Weaknesses or Exploits in the Field of Cryptography** - You acknowledge and understand that Cryptography is a progressing field. Advances in code cracking or technical advances such as the development of quantum computers may present risks to cryptocurrencies, Digital Assets and Services, which could result in the theft or loss of your Digital Assets or property. To the extent possible, it is intended to update the protocol underlying the Services to account for any advances in cryptography and to incorporate additional security measures, but does not guarantee or otherwise represent full security of the system. By using the Services or accessing the Site, you acknowledge these inherent risks.

**3.9 - Volatility of Cryptocurrency** - You understand that Ethereum and other blockchain technologies and associated Digital Assets, currencies or tokens are highly volatile due to many factors including but not limited to adoption, speculation, technology and security risks. You also acknowledge that the cost of transacting on such technologies is variable and may increase at any time causing impact to any activities taking place on the Ethereum blockchain. You acknowledge these risks and represent that Algo Foundry or/and Undercurrent Capital and/or Algorand Foundation cannot be held liable for such fluctuations or increased costs.

**3.10 - Your Content** - You hereby grant to us a royalty-free, fully paid-up, sublicensable, transferable, perpetual, irrevocable, non-exclusive, worldwide license to use, copy, modify, create derivative works of, display, perform, publish and distribute, in any form, medium or manner, any content that is available to other users via the Algo Foundry Platform as a result of your use of the Portal (collectively, "Your Content") through your use of the Services or the Portal, including, without limitation, for promoting Algo Foundry (or its Affiliates), the Services or the Portal. You represent and warrant that: (a) you own Your Content or have the right to grant the rights and licences in these Terms; and (b) Your Content and our use of Your Content, as licensed herein, does not and will not violate, misappropriate or infringe on any third party's rights.

#### **4. PRIVACY**

## **5. PROPRIETARY RIGHTS**

**5.1 - Ownership of Services;** License to Services Excluding any open source software (as further described in Section 5.2) or third-party software that the Portal or the Services incorporates, as between you and Algo Foundry, Algo Foundry owns the Portal and the Services, including all technology, content and other materials used, displayed or provided on the Portal or in connection with the Services (including all intellectual property rights subsisting therein), and hereby grants you a limited, revocable, transferable, license to access and use those portions of the Portal and the Services that are proprietary to Algo Foundry.

**5.2 - Trademarks** - Any of Algo Foundry's product or service names, logos, and other marks used in the Portal or as a part of the Services, including Algo Foundry's name and logo are trademarks owned by Algo Foundry, its Affiliates or its applicable licensors. You may not copy, imitate or use them without Algo Foundry (or the applicable licensor's) prior written consent.

## **6. CHANGES; SUSPENSION; TERMINATION**

### **6.1 - Changes to Services**

We may, at our sole discretion, from time to time and with or without prior notice to you, modify, suspend or disable, temporarily or permanently, the Services, in whole or in part, for any reason whatsoever, including, but not limited to, as a result of a security incident.

### **6.2 - No Liability**

We will not be liable for any losses suffered by you resulting from any modification to any Services or from any suspension or termination, for any reason, of your access to all or any portion of the Portal or the Services.

### **6.3 - Survival**

The following sections will survive any termination of your access to the Portal or the Services, regardless of the reasons for its expiration or termination, in addition to any other provision which by law or by its nature should survive: Sections 1, 4, 5, 6.3, and 7-14.

## **7. ELECTRONIC NOTICES**

You consent to receive all communications, agreements, documents, receipts, notices, and disclosures electronically (collectively, our "Communications") that we provide in connection with these Terms or any Services. You agree that we may provide our Communications to you by posting them on the

You will defend, indemnify, and hold harmless us, our Affiliates, and our and our Affiliates' respective shareholders, members, directors, officers, employees, attorneys, agents, representatives, suppliers and contractors (collectively, "Indemnified Parties") from any claim, demand, lawsuit, action, proceeding, investigation, liability, damage, loss, cost or expense, including without limitation reasonable attorneys' fees, arising out of or relating to (a) your use of, or conduct in connection with, the Portal; (b) Algorand Blockchain assets associated with your Algorand Address; (c) any feedback or user content you provide to the Portal, if any; (d) your violation of these Terms; or (e) your infringement or misappropriation of the rights of any other person or entity. If you are obligated to indemnify any Indemnified Party, Algo Foundry (or, at its discretion, the applicable Indemnified Party) will have the right, in its sole discretion, to control any action or proceeding and to determine whether Algo Foundry wishes to settle, and if so, on what terms.

## **9. DISCLOSURES; DISCLAIMERS**

Algo Foundry is a developer of open-source software. Algo Foundry does not operate a virtual currency or derivatives exchange platform or offer trade execution or clearing services and therefore has no oversight, involvement, or control with respect to your transactions. All transactions between users of Algo Foundry open-source software are executed peer-to-peer directly between the users' digital wallets through a smart contract. As a user of Algo Foundry, you declare that you are not a citizen or resident of any jurisdiction in which either the use of any of the Services, exchange, purchase, receipt, or holding of any Tokens is prohibited, restricted, curtailed, hindered, impaired or otherwise adversely affected by any Applicable Laws;

## **10. EXCLUSION OF CONSEQUENTIAL AND RELATED DAMAGES**

## **12. GOVERNING LAW AND DISPUTE RESOLUTION**

12.1 These Terms shall be governed by, and construed in accordance with, the laws of the Republic of Singapore

Any dispute arising out of or in connection with these Terms, including any question regarding its existence, validity or termination, shall be referred to and finally be resolved by arbitration in Singapore in accordance with the rules of the SIAC for the time being in force, which rules are deemed to be incorporated by reference in this paragraph. The seat of the arbitration shall be Singapore. The tribunal shall consist of a sole arbitrator to be appointed by the Chairman of the Page 18 SIAC. The language of the arbitration shall be English. This arbitration agreement shall be governed by the laws of the Republic of Singapore. Each of the Parties irrevocably submits to the non-exclusive jurisdiction of the courts of Singapore to support and assist the arbitration process pursuant to these Terms, including if necessary the grant of interlocutory relief pending the outcome of that process.
